How can AI techniques be used to successfully detect cartels in public procurement? Normally, when talking about collusion in public procurement, the starting point is a classic tendering model, but purchasing entities have implemented new procurement techniques (for example, reverse auctions, consolidated purchases): What experiences have competition authorities had with these new procurement models? What are some of the new challenges (prevention, detection, and investigation) that agencies are facing when dealing with bid-rigging cases? Likewise, other public procurement schemes and the way agencies have approached the study of collusion in said formats could be discussed.
